Re: Professional Development

Dear Mr. Fisher:

Please find attached a tentative outline of the two professional development days which would occur on August 31, 2021 and September 1, 2021 prior to the first day of school. As you will note, if the District and SCTA reach agreement to add these two days to the work calendar for SCTA unit members, the first day consists of professional learning provided by the District's C&I team and focuses on High Quality Instruction, including UDL, MTSS and Anti-Racist classrooms. There will be three periods of time within the morning for each segment (elementary, middle, high) to select from learning opportunities in each of the above referenced areas. This will allow our educators the opportunity to select from professional learning opportunities that are most relevant to their work and focus for the upcoming school year. The afternoon of the first day will consist of professional learning lead by site administrators focused on site based initiatives and goals.

On day two, there will be a self-guided module from EPOCH Education that will take approximately 4 hours for staff to begin the work in addressing implicit bias. Please see the link to the EPOCH program. This will be the first step of a long-term program and will focus on "compassionate dialogue." The afternoon of the second day would again allow the sites to focus on site based initiatives and goals. Again, the pre-service PD day is only the beginning and is intended to lay the crucial foundation for the important work necessary to address implicit bias.
