### **Full Day Preschool**

The purpose of the full day option is to provide child care for families.

- Class capped at 13 students
- Monday-Friday
- Student hours 8:00-3:00 (student hours may be staggered at Elder Creek for social distancing during drop off and pick up)
- Teacher hours 7:30-4:00
- CCAs assigned 3 hours if attending students is over 8
- Parents requesting distance learning will be offered a different site
- Weekly student activity sheet and zoom classrooms will not be required

#### **School Age Children's Centers**

The purpose of the School Age Children's Centers is to provide child care for families.

- Monday Friday
- Student hours 7:45-3:45
- Teacher hours 7:30-4:00
- Students may attend in-person class on their scheduled day and return to the center or can be in full distance learning.
- Maximum of 14 students will be enrolled regardless of the number of days of care needed. Drop in and variable schedules will not be allowed.

#### First 5 Infant/Toddler Playgroups (two teachers)

Because parents are required to attend with their child, playgroups will continue with distance learning. As the county moves into less restrictive tiers, teachers may be able to have outdoor socials in the community.
